9. Fresh Health Certificate from M.C.D. shall be obtained and produced to the E.O. for verification.
10. The Managing Committee shall regulate the functioning of school strictly in accordance with the provisions of DSEA and R, 1973.



ORDER

WHEREAS, Mother Khazani Convent School, Mungeshpur Delhi (SCHOOL ID-1310277), was an unaided private recognised school under Directorate of Education, GNCTD governed by the provisions of Delhi School Education Act and Rules, 1973. The school was recognized from Class I to VIII by DoE vide order dated 24.02.1994 & granted the upgradation from Middle to Secondary vide order dated 24.06.1996 and provisionally recognized from Secondary to Sr. Secondary in Arts & Commerce streams vide order dated 17.10.2003.

AND WHEREAS, vide order dated 09.05.2018 issued by Dy. Secretary (Aff.)/CBSE, the provisional affiliation for Secondary and Senior Secondary level granted to the school was withdrawn as per penal provisions given under Rule 17 2a (xi) of Affiliation Bye Laws of the Board.

AND WHEREAS, the recognition of the school was withdrawn by the Directorate of Education vide order dated 04.03.2021 on the request of CBSE with allegation that the school has failed to exercise its control over its staff members who were indulged in leakage of Economics paper on 26.03.2018. The school was further directed not to admit any new student onwards with effect from 31.03.2021 for the session 2021-22.

AND WHEREAS, the management of the school filed an appeal before the Hon'ble Court of LG of Delhi vide Case No. 21/2021 under section 4 (7) read with rule 58 of DSEA&R, 1973 and the same was rejected vide order dated 02.06.2021.

AND WHEREAS the management of the school filed three Writ Petitions (Civil) in Hon'ble High Court of Delhi vide WPC No. 1925/2019 & 7368/2020 & 8959/2021 titled as Khazani Delhi Educational Society vs CBSE & Ors. with a pray to restore the affiliation & recognition and to set aside the order dated 02.06.2021 of Hon'ble Court of LG. The Hon'ble High Court of Delhi has given the following directions vide order dated 07.12.2023:-

After brief hearing Learned Counsels for both the parties, it transpires that since the period of disaffiliation of the school is already over, it is available to the school to apply again for restoration of affiliation to respondent No.1/ Central Board of Secondary Education (CBSE).

Learned Counsel for the petitioner submits that since the 'recognition' would be the threshold requirement, prior to filing for restoration of 'affiliation' the school would first file a representation before the DoE for obtaining 'recognition'.

Let the school apply to the DoE for recognition within 02 weeks; which application shall be decided by the DoE within 02 weeks thereafter.

Let an application for restoration of affiliation be filed before the CBSE, as may be permissible in accordance with the CBSE Affiliation Bye-Laws, as and when application for affiliation are open for the ensuing academic year.

AND WHEREAS an inspection committee was constituted under Chairmanship of DDE (NW - A) vide order dated 10.01.2024 and the committee visited the school premises on 12.01.2024 & submitted its detailed report. The inspection committee submitted in its report as under:-

"The plea taken by school management seems genuine and humane that punishment of few mischievous employees who might have got indulged in the said case, cannot be given to the other stake holder like parents, students, teachers, non-teaching staff of the institution as it will be a grave injustice with those stake holders who are never involved in the matter directly or indirectly but due to de-recognition they are in critical condition as a bread earner for their families.

There is no doubt that the school has built a huge infrastructure worth crores of rupees and made all possible efforts for the society and students. Seeing that the school has satisfied both the condition of Rule 57 for restoration of recognition, therefore in the academic interest, welfare of students and all the employees along with their families the case for restoration of recognition may be consider."

AND WHEREAS District DDE North West - A recommended that "the case is fit for restoration of recognition."

AND WHEREAS the rule 57 of DSER, 1973 provides:

Restoration of recognition:

"Recognition once withdrawn or lapsed shall not be restored until the appropriate authority is satisfied that the reasons which led to the withdrawal or lapse of recognition have been removed and that in all other respects the school complies with the provisions of the Act and the rules made there under."

NOW THEREFORE, in compliance of the directions passed by the Hon'ble High Court of Delhi vide order dated 07.12.2023 in WPC No. 1925/2019 & 7368/2020 & 8959/2021 titled as Khazani Delhi Educational Society vs CBSE & Ors and in exercise of the power vested under rule 57 of DSER, 1973, the Competent Authority i.e. Hon'ble Lt. Governor, National Capital Territory of Delhi is pleased to accord his kind approval to restore the recognition of Mother Khazani Convent School (ID-1310277), Mungeshpur, Delhi from Class I to Sr. Secondary (with Arts & Commerce stream) on provisional basis w.e.f. academic session 2024-2025 upto 31.03.2029 under Rule 57 of DSER, 1973 subject to the following terms & conditions:-

1. Final outcome of the notification of MoUD, Govt. of India.
2. That the school shall comply with the provisions of RTE Act, 2009, DSEAR, 1973 and directions/instructions issued by the Department from time to time.


